AN ORDINANCE OF THE TOWN OF OXFORD TO AMEND CHAPTER 5 OF THE OXFORD TOWN CODE TITLED “TRASH COLLECTION” TO ADD SECTION 5.2 AUTHORIZING THE ESTABLISHMENT OF A TRASH COLLECTION POLICY BY RESOLUTION AND RENUMBERING FORMER 5.2 AS SECTION 5.3, AND INCREASING THE AMOUNT OF A MUNICIPAL INFRACTION FOR A VIOLATION OF CHAPTER 5 TO \$50.00 PER VIOLATION

WHEREAS, the Town of Oxford is authorized by the Maryland Code Ann. Local Government Article § 5-202 to adopt such ordinances not contrary to the Constitution of Maryland, public general law, or public local law as it deems necessary to assure the good government of the municipality, to preserve peace and order, to secure persons and property from damage and destruction, and to protect the health, comfort and convenience of the citizens of the municipality; and

WHEREAS, the Commissioners of Oxford are authorized to provide for the publication and codification of all laws, ordinances, resolutions, or regulations adopted by the municipality; and

WHEREAS, the Commissioners have determined that it is desirable and in the public interest to amend Chapter 5 of the Oxford Town Code, titled “Trash Collection” by adding a new Section 5.2 to authorize the establishment of a trash collection policy by resolution from time to time, and by renumbering former Section 5.2 as Section 5.3, and increasing the amount of a fine for a violation of Chapter 5 from \$10.00 to \$50.00.

NOW, THEREFORE, the Commissioners of Oxford hereby ordain as follows:

Section 1. The Oxford Town Code, Chapter 5 is hereby amended as follows:

CHAPTER 5. TRASH COLLECTION

- 5.1 Trash Collection
- 5.2 Establishment of Trash Collection Policies
- 5.2 Violations; Penalties

Section 5.1 Trash Collection.

All residential household trash that is placed on the public way for collection shall be kept or enclosed in a container or receptacle to enable the collector to remove it quickly and efficiently.

Section 5.2 Establishment of Trash Collection Policies.

The Commissioners shall be authorized to establish a trash collection policy or policies from time to time by the adoption of a resolution, including the establishment of violations and penalties.

Section 5.3 Violations; Penalties.

A violation of this Chapter, *or any resolution adopted pursuant to this Chapter*, shall constitute a municipal infraction and shall be subject to a fine of not less than *fifty dollars (\$50.00)*. ~~ten dollars (\$10.00)~~. Each day that a violation continues shall constitute a separate offense.

Section 2. This Ordinance shall take effect on the _____ day of _____, 2019.

Section 3. This ordinance and the rules, regulations, provisions, requirements, orders and matters established and adopted hereby shall take effect and be in full force and effect twenty (20) days from and after the date of its final passage and adoption.
